**CALL FOR PROPOSALS: RESEARCH CHAIR PROFESSORS**

**Subject:** Guidelines and invitation of proposals for "Research Chair Professors" funded by the IoE - Reg.

The University of Hyderabad seeks to appoint, in line with the recommendations made by the Empowered Expert Committee for the Institution of Eminence scheme of the Government of India, and communicated to the University vide UGC letter dated 30 June 2020, "Research Chair Professors".


The institution of this Chair Professor is meant to provide inspirational and high-profile researchers in the University's academic units, for varied periods of time.

***Eligibility***

- i) A scholar of eminence who has made significant contributions to a field of study of profession may be considered for appointment to Chair Professor without age limit.
- ii) We seek to appoint senior scholars of global repute with an exemplary research and publication record that is internationally documented and visible, and who are still academically active, producing high quality work that will contribute continually to the University's IoE profile.
- iii) A total of 3-4 such Professorships for the entire University will be instituted depending on the quality of candidates.
- iv) The Chair Professor is entitled to Rs 1,20,000 per mensem as emoluments.
- v) The tenure of the Chair Professorship will be fixed based on the availability of the selected candidates and the requirements of the academic unit.

### ***Application and Selection***

- Schools and Departments are invited to send up nominations and names (maximum of a panel of 3 names) from any institution to the Vice Chancellor. Schools and Departments are encouraged to submit proposals for “Research Chair Professorship in ..... ”, with complete CVs, of eminent faculty in their disciplines. The Department or School proposing will seek and obtain the approvals of their respective Boards. A sound rationale must be offered for (i) the Chair Professorship, (ii) each of the candidates on the panel.
- The Chair Professor should add scholarly visibility to the Dept/School and the University and proposals should clearly demonstrate both range and depth of the candidates’ scholarly output over the years, particularly in terms of internationally indexed publications.
- Chair Professors will contribute to the Research Programs of the School/Dept appointed to, and they are not meant to service the regular teaching needs of the unit, or address gaps in them.
- As far as possible the proposal should recommend persons in domains that would be unusual for an Indian university, so units are advised against proposing generically structured positions such as “Research Chair Professor in Life Sciences”. Short-term positions are also possible, depending on the availability of the incumbent.
- The panel may then be referred to an Expert Committee for their views.
- A final decision will be taken by the Vice Chancellor.
