CIRCULAR

All the students' of Integrated Masters' and Master's Programme, belonging to the categories of SC, ST, BC, Disabled, EBC & Minority and eligible to register for the Post-Matric Scholarship of the Social Welfare Department, Govt. of Telangana are hereby informed that the last date for applying Post-Matric Scholarship for the A.Y. 2021-22, is **31-01-2022**. For details, please visit <https://telanganaepass.cgg.gov.in/>.

After applying for Post-Matric Scholarship (Fresh or Renewal) for the year 2021-22, the students shall submit the Hard Copy of their application along with the following documents for the Physical Verification duly attested by the Gazetted Officer, **within a period of 15 days from the date of application:-**

- Copies of educational qualifications from SSC and previous Qualifying Certificate
- Copies of Caste Certificate, Aadhar Card, Bank Passbook
- Income Certificate (Original) – Fresher
- Affidavit declaring the annual Income of the family (Original) – Renewal
- Copies of the Conditional Admit Card and Semester Registration
- Copies of bonafide / conduct certificates of last 07 years
- Hostel Residence Certificate (Original), for Hostellers (College Attached Hostel)
- Copy of the Transfer Certificate (for Fresher)
- Copy of the GAP Certificate, if applicable
- Copies of Aadhar Card, Bank Passbook

Mere submission of application on e-Pass does not entitle the student for consideration to sanction Scholarship by the Govt. of Telangana, unless the physical verification & Aadhar authentication by the student is completed and forwarded to the Social Welfare Department.

All the students are hereby advised to send the Hard Copy of application along with the above documents, by SPEED POST to the following address for verification at the University:-
