The following documents need to be submitted together with the e-submission:-

- Signed and dated **soft copy (preferably pdf)** of the proposal in the **application format enclosed in notification 1 & 2 available on website.**
- (1) One Hard copy & (1) One soft copy of the proposal document not exceeding 3 pages duly signed by all participating investigator/collaborators **directly to Ms. Meharunnissa** – School of Medical Sciences Office.
- **Participant Information Sheet & Informed consent form** in lay – simple local language.
- **A brief CV of the Principal Investigator** if they are applying for the first time to IEC of UoH.
- **Proposals submitted by scholars/students should be duly signed and forwarded by the Guide/Supervisor.**
- **Clearly indicate whether you seek virtual data collection option in the form.**
- **IEC approval of the other participating Institute,** if any.
- **Permission letters** from collaborating/partnering centres.
- Proposals related to stem cell research/therapy should be sent to both IEC and IC-SCRT.
- **Applications for renewal/extension (as applicable) of the project should be sent along with the annual update of the proposal/progress report with prior IEC approval details.**
- Major changes in protocol/methods will require a new application submission (**see earlier notification**) and cannot be considered for extension.
- Information on funding/sponsorship if applicable.
- Any other information (eg. transfer of biological samples, international collaborations, insurance, clinical trial approval, dossier, permission letters etc.)

The Principal Investigators or Co-Investigators will be required to be ready with a brief presentation (5-7 minutes) of the proposal **if subjected to full review** and/or respond to the queries if asked for. Request the Deans and Heads of Department to kindly disseminate the information to all faculty and students.
