ORDER

M/s INKARP Instruments Pvt. Limited, Hyderabad, which was blacklisted, vide Order No. UH/EC & Legal/2022/1024 dated 03.03.2022, for a period of 3 years due to the inordinate delay made by them during the period 2019 to 2021 in the supply of a High Speed Centrifuge, which was to be imported from M/s Kubota Corporation Pvt. Ltd, Bunkyo-Ku, Tokyo for the School of Chemistry, resulting in the lapse of the sanction issued by the Department of Biotechnology, Ministry of Science & Technology.

In a meeting convened at the request of M/s INKARP Instruments Pvt. Ltd with the Dean and Faculty concerned of the School of Chemistry, representative of the Finance Officer and the Internal Audit Officer, the representatives of the firm had tendered unqualified apology and agreed to make good the loss, equivalent to Rs. 11,46,146/- towards costs, damage, penalty and compensation to the University, partly in cash and partly by way of supply of equipment/materials free of cost, to facilitate the University to consider revoking of the blacklisting order.

In compliance with the agreement, M/s. INKARP Instruments has paid the amount of Rs. 8, 07,047/-(vide Receipt No. 99 dt.21.6.2022 of Book No.846 and Receipt No.013 dt.27.06.2022 of Book No.851) and supplied materials worth Rs.3,39,099/- free of cost to the School of Physics vide D.C No.IIS/22-23/264 dt.21.06.2022, fulfilling its part of the agreement.

Since M/s INKARP Instruments Pvt. Ltd. fulfilled its assurances in pursuance of the agreement, the Order No. UH/EC & Legal/2022/1024 dated 03.03.2022 blacklisting the firm is revoked with immediate effect, facilitating the supply of materials/ equipment and provide maintenance services etc. by the firm to various user Departments/ Schools of the University.
